Dam spillway/drain rehabilitation

The old/damaged corrugated metal pipe was successfully "slip-lined" with a 70 foot long, 24 inch diameter, fiberglass reinforced polymer mortar pipe. After slip-lining, the space between the new pipe and the old pipe was grouted, and the entrance of the pipe was sealed with concrete. All of the work was performed in compliance with DNR requirements, and supervised by an engineering firm. There should be no fears of any additional erosion damage.
