## **Budget Discussion**

- Approximately \$378K in the whole budget may have around \$175K to spend for this year (generalized statement).
- The treasurer proposed a plan to get the monthly expenditures reviewed.

## Membership

- 98% of the houses are paid, and 17 class C homes
- 2 homes are delinquent
- Board Action Gina proposed to put liens on those two homes for this year's fees, the Secretary seconded it, and it passed unanimously

### **Activities**

- Mobile blood drive is booked out 4 months, so might do it at the chili cookoff
- Sherri recommended a Sign Up Genius for the 4th of July party so that she will send that out.
- Sherri wants a map of the neighborhood to see where she can put the signs.

#### Pool

- The drain work was done a couple of years ago in the deep end
- The pool is disintegrating in the shallow end
- Plaster lasts about 7-10 years, the plaster repair is about \$53K
- \$53K is more permanent
- \$3750 to prepare the part of the pool that is coming up, total with water loss is about \$5K
- \$5K repair will require the pool to be closed for about 4 days, and we want to do it when the swim team has finished and before or after the Fourth of July weekend; there would be no guarantee on the work
- Leaving the pool unrepaired is a safety issue
- Board Action: Spend \$5K to patch the pool to prevent any additional minor injuries, the president made the motion, the secretary seconded -> passunanimous
- The baby pool technically requires a fence around it (within 5 feet of the pool)
- The planter may need to be torn out
- Main repairs required
  - Baby pool repair with fence installation
  - Plaster in the pool
  - Coping repair the material used for the edging or capping that surrounds the top perimeter of a swimming pool

#### Grounds

- Quote to clean up the trees around the communal property (\$11K), some removal, but mostly trimming (Cundado Services)
- The dam inspection is next month
- Board Action: Spend \$11K to clean up the trees around the clubhouse property, the president made the motion, the secretary seconded -> pass-unanimous

#### Clubhouse and Facilities

- Robison Company is starting the work on the installation
- How long do we want to retain the video? The lawyer recommended 90 days. Currently, we have 30 days with our drive storage
- Clubhouse motioned that we spend \$300 extra to obtain a 60-day storage drive, seconded by Gina, passed - unanimous
